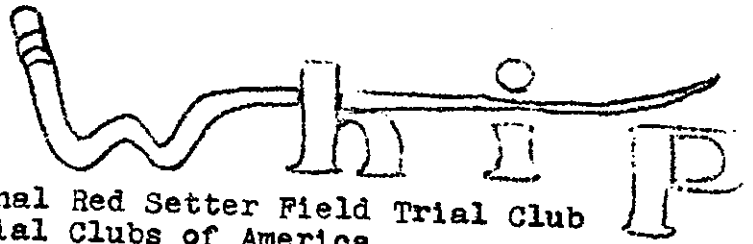

LODGING: No camping is allowed at the wildlife area so those from out of town might consider staying at the Prairie Ridge Motel, just  $\frac{1}{2}$  mile east of the Kopper Kettle (where banquet & drawing are to be held & located at Highway 50 and by pass 71). This is  $1\frac{1}{2}$  miles west of wildlife area. Write to Box 13, R. R. 1, Lee's Summit, Mo. Phone 816 271 2278. (Rooms are \$5, \$7 & \$8.)

Holiday Inn on Highway 50 is 11 miles west of Kopper Kettle with mailing address 8500 Blue Park Way, Kansas City, Mo. (Has own restaurant and is \$8 & \$10 for one person and \$10 and \$12.50 for two).

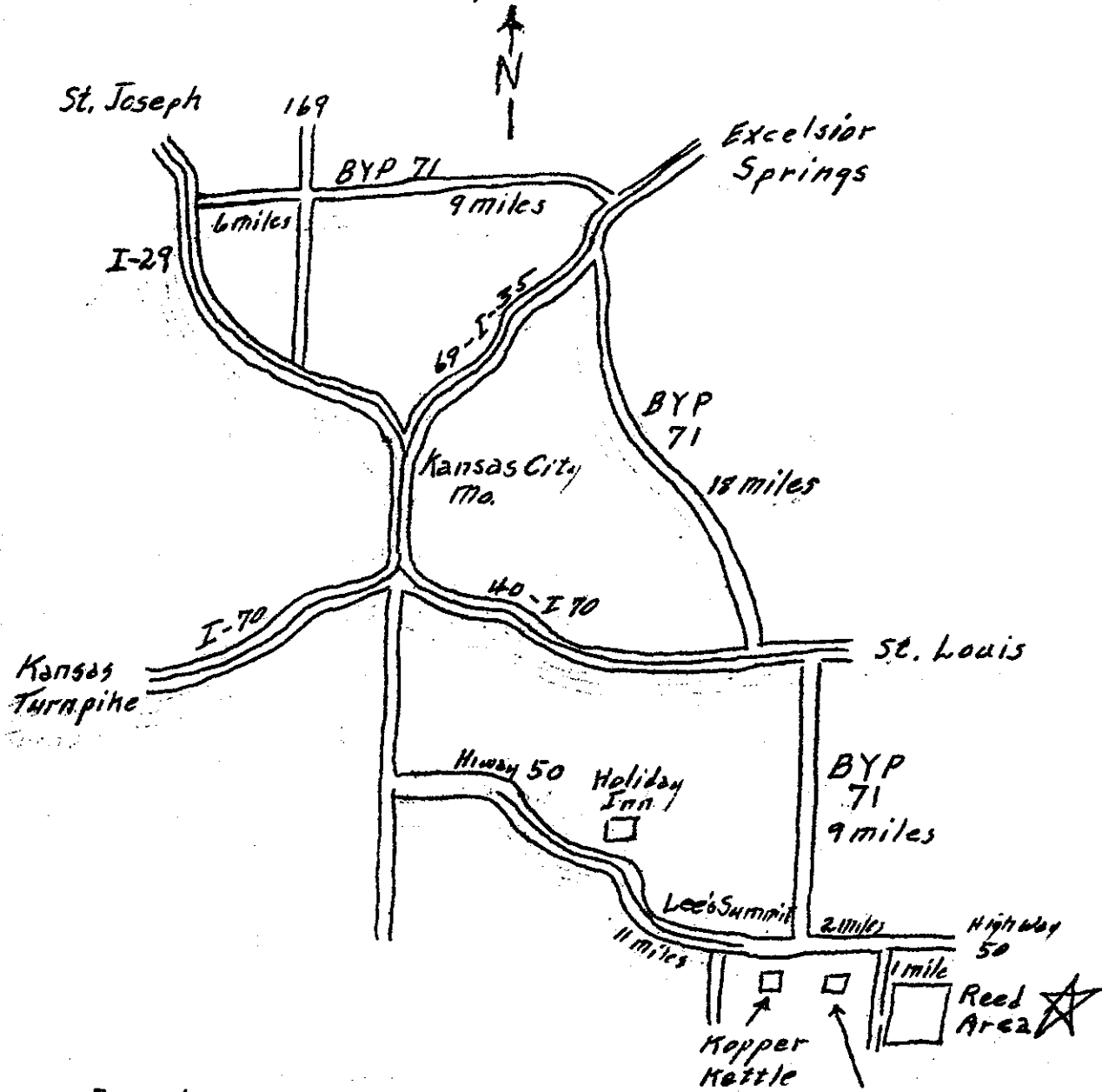

Mr. Little has asked that the National's board of directors consider a fall trial in N. Y. in 1966 thus giving the eastern half of the NRSFTC's members a chance to see and enter. Baldwinsville where most of the shooting dog futurities and the National Pheasant championship events are held.

Our present plan is to retain Kildeer Plains, near Upper Sandusky, Ohio for the spring classic and move about in the fall to the different areas giving and testing for attendance and support where a successful trial. The club after all was founded for the purpose of bettering the breed. To do this we have felt gave people a chance to see what different areas and different breedings have come up with . . . so think about it . . . and then let your feelings on the subject be known.

Cliff has asked for the first or second week-end in April for Kildeer Plains. Notice of their date selection meeting as Sept. 12 has been in the mail and Dale Lynd, Associated Bird Dog Clubs of Ohio notified of our preference. At their July meeting in Columbus a resolution was passed that in case an individual fails to pay entry fee for a dog that has been drawn to run the Sec. of the Assoc. Bird Dog Club will advise him that he has 30 days to pay or appeal to assoc. If after 30 days and he has done neither he will be barred from competition in any Assoc. trials. (We are members.) It was also decided that any club using the grounds be responsible for its clean-up. Winners of the Dogs of Year Awards were announced and certificates given. Tabulation of points listed Bean's Mr. O'Leary with 31; Windyridge Tammy with 4; Windyridge Nack with 3; Jim Lewis' Golden Hoss Colt with 30 and Jim Flthe's Turkey Talk Red with 15! Nice going! Final tabulations aren't out yet but this is the midyear tabulation.

Have to see what the Flythe dog "Tom" does after he gets him back from Paul Long! He's the smiling one Jim brought to the spring went. Jim's not sure on the fall trial but hopes to get to midwest for pheasant hunting at least.
